TERMS AND CONDITIONS OF - SIP PAUSE FACILITY

- 1. Pause is applicable to all Schemes except ULIP.
- 2. Pause facility will be available for Monthly or Quarterly Frequency.
- 3. Pause is applicable to all SIP modes except the mandates registered under Standing Instruction Mode with Direct Debit Banks.
- 4. Pause can be registered only after successful completion of 6 instalments from the date of SIP registration.
- 5. Pause can be registered for a minimum of 1 Month and a maximum of 6 Months for Monthly Frequency and Minimum of 1 Quarter and Maximum of 2 Quarters respectively for Quarterly Frequency.
